Important Information Regarding Investments in UESP—Performance returns are based on a \$10,000 account balance, assuming the funds were invested on the first day of the period and held until the last day of the period shown. These are the performance numbers of the investment options, not individual accounts. Beginning January 1, 2010, returns do not reflect the annual Administrative Maintenance Fee (up to \$15), which is waived for all Utah residents and for non-Utah residents who choose to view their quarterly account statements online rather than receive them in the mail. Actual performance for non-Utah residents will be lower if the annual Administrative Maintenance Fee is charged. Returns for investment Option 3, starting March 1, 2010, reflect the change in asset allocation mix that occurred on February 26, 2010. Returns for the Age-Based Aggressive Growth, Age-Based Moderate, Age-Based Conservative, and Equities—10% Total International investment options, starting May 6, 2011, reflect the fund exchange from the International Value Fund and the International Growth Fund to the Total International Stock Index Fund. Returns for the Age-Based Growth and Option 3 investment options, starting August 19, 2011, reflect the fund exchange from the Institutional Index Fund to the Total Stock Market Index Fund. Returns for the age-based options, excluding the Customized Age-Based investment option, reflect the asset allocation change that occurred on August 22, 2011. Except for the underlying investment in the FDIC-insured savings account held in trust by UESP at Zions First National Bank (Bank), investments in UESP are not insured by the Federal Deposit Insurance Corporation (FDIC). Subject to the application of Bank and FDIC rules and regulations to each account owner, investments in the FDIC-insured savings account will retain their value. Funds in the savings account are insured by the FDIC on a pass-through basis to each account owner up to the maximum amount set by federal law, which is \$250,000. The amount of FDIC insurance is based on the total of (1) the value of an account owner's investments in the FDIC-insured savings account plus (2) the value of an account owner's other accounts held (if any) at the Bank, as determined by the Bank and by FDIC regulations.
