

# Age-Based Investment Options

In UESP's age-based options, assets are automatically exchanged from one age bracket to the next as the beneficiary ages (on the business day following the beneficiary's birthday) according to the table below. None of the options provide a guarantee of any level of performance or return.

\*Contributions made to the underlying FDIC-insured savings account are held in trust by UESP at Zions First National Bank (Bank). Funds in the savings account are insured by the FDIC on a pass-through basis to each account owner up to the maximum amount set by federal law—currently \$250,000. The amount of FDIC insurance provided to an account owner is based on the total of (1) the value of an account owner's investment in UESP's FDIC-insured savings account plus (2) the value of other accounts held (if any) at the Bank, as determined by the Bank and by FDIC regulations.

\*\* UESP will reallocate the funds to the "Age 19+ or College Enrolled" age bracket on age-based accounts when a qualified withdrawal request is submitted by the account owner/agent indicating that the beneficiary is enrolled in an eligible educational institution or when the beneficiary turns age 19, whichever comes first.
